AS WE WERE... Part II 113 Years of the Evansville Audubon Society

In Part I of our stroll down memory lane in the previous newsletter, we were in the 1970's. At this time, the Evansville Audubon Society became more involved with the total environment, not just birdwatching. The Society's first conservation project offered free trees to the public. Members presented educational programs to various groups, with a wide range of topics on nature and conservation. Also, the Society sponsored environmental poster and essay contests for elementary and high school students.

In the spring of 1972, members built a bluebird trail at the ISUE (now USI) campus. Twenty-two nest boxes were built and monitored, which helped in the bluebird's rapid recovery.

In 1974, among the many field trips offered, was the memorable "Let's Graze for Lunch" (gathering of edible plants) at ISUE's (now USI) Westwood Lodge. This popular outing continued for a decade.

In 1979, the Society began selling wild bird seed as a fundraiser (there were few local sources at the time)—members received a 10% discount. The sales continued until 2002; when, by that time, many commercial businesses sold bird seed.

In 1980, when there was only one known Barn Owl nesting site in Indiana, Society members constructed and placed twenty-five owl nesting boxes in Vanderburgh County.

From April to June, 1983, the Science gallery of the Evansville Museum of Arts and Science exhibited an "Audubon Today" display! Prints and slides represented all phases of Evansville Audubon activities, field trips, and local flora and fauna.

In 1985, the Society co-sponsored with Wesselman Park Nature Center an Ohio Valley Acid Rain Symposium. From 1988 thru 1991, as part of the Citizens Acid Rain Monitoring Network (Evansville area), an Evansville Audubon member diligently took measurements as Acid Rain Monitor.

In 1986, we began working with many organizations in a long effort to establish the Patoka River National Wildlife Refuge. By 1989 endorsements were obtain from Senator Lugar, Governor Bayh, and Congressman McCloskey. The Refuge was successfully established in 1994. Also, the Society successfully obtained a grant to establish the Friends of the Refuge group in 2010.

During the 1990's, the Society offered a series of Bird ID Workshops, conducted a survey of bird species along the Pigeon Creek Greenbelt, observed and recorded data for the Peregrine Falcon release project in downtown Evansville, and became part of a coalition to form Friends of Ayrshire to support the Indiana DNR purchase of reclaimed mine land to become Blue Grass FWA.

Our activities in the 2000's would take up another page (Ohio Valley Birding Festival, Climate Change lecture, etc.), but I hope that you have enjoyed this brief look at the Evansville Audubon Society and that you will become inspired to join our organization, if you are not already a member, to continue our efforts into the next century!

HAPPENINGS on the PATOKA RIVER NATIONAL WILDLIFE REFUGE:

Peent! An Evening with the Woodcocks

Saturday evening, March 1, the Refuge Friends will offer a unique birding experience for the whole family. Most outings aren't focused on just one animal, but woodcocks are so neat they get a whole night all their own!

Just what is a "Peent"? It's the sound made by male woodcocks while performing their courtship ritual flights. Join us at Columbia Mine Preserve main parking lot on Patoka River National Wildlife Refuge at 5:30 pm CST for a brief presentation on the woodcock. Then we'll walk Timberdoodle Trail and hope the woodcocks are in the mood to put on a show.



This event is open to all, regardless of age or experience. Yet, since this is an event in the evening that is dependent on a fairly quiet environment, parents are encouraged to stay with their children. Dress appropriately for the weather and wear comfortable walking shoes. Flash lights are optional. Consider arriving early to enjoy the sunset and walk some trails. In case of inclement weather, the event will be held on March 2.

Directions: Head east from Oakland City on State Highway 64 for two miles to CR 100W. Turn left (North) onto CR 100W and continue 3/4 mile until the road "T's". Turn Left (West) on W CR 475 S, travel 1/10 mile. Look for the Columbia Mine Preserve sign across from Patoka Grove Church, turn right (North) onto CR 125W and follow the road two miles back to the large parking area at the center of the Columbia Mine Preserve.

Program: at 6:00 PM – Brad Bumgardner, Executive Director of Indiana Audubon, gave a presentation on "Update on the Chasing Melody Wood Thrush Motus Tagging & other Indiana Audubon Projects" virtually through Zoom.

The business meeting convened at 6:55pm after the program concluded. A quorum was present with ten board members - Brian Taylor, Richard Vernier, Sue Vernier, Niles Rosenquist, Jim Kimsey, Pam Kimsey, Phil Copp, Pat Copp, Alex Gansmann and Hope Hartman.

Minutes: The November 2024 meeting minutes were approved.

Treasurer's report: Richard Vernier gave the treasurer's report as of 12/31/2024.

Committee Reports:

Field Trips- Sue Vernier gave results of the Owl Prowl held on Sunday the 8th. A Ky. Dam trip is scheduled for February 1st.

Programs- The March 18th program "Hummingbirds of New Mexico and Arizona" will be presented by Richard and Sue Vernier.

Junior Birders- Sue Vernier let everyone know the Jr. Birders Facebook page will be replaced by a webpage on www.evvaudubon.org. Hope Hartman announced they will be participating in the Great Backyard Bird Count from 2/14-17/2025. The site is www.birdcount.org.

Advocacy- Sue Vernier told about the Audubon Great Lakes Advocacy Day at the Indiana Statehouse on March 10th (11-4pm ET). Niles Rosenquist mentioned HB 1447 and SB 321 concerning an energy bill to restrict coal and use small nuclear power.

Education and Conservation Grants- Sue Vernier presented grant requests under new business. **Events** – No update

Media/Marketing- Brian Taylor gave an update on the email newsletter delivery rates.

Old Business:

Sue Vernier reported there is still a vacancy for the program chair.

National Audubon approved an Evansville Audubon Society collaborative grant application for \$560 to fund MOTUS tagging for one Wood Thrush in 2025. The check was mailed to Indiana Audubon.

New Business:

A motion was made by Brian Taylor and seconded by Niles Rosenquist to approve an education and conservation grant request from Sycamore Land Trust for \$1,000 to support Eagle Slough Natural area and provide funding for restoration, trail maintenance, and monitoring.

Sue Vernier reported that the Annual Chapter Certification Report was submitted to National Audubon and was approved.

Sue asked for volunteers for the Nominations Committee. Alex Gansmann and Brian Taylor offered to be on the committee. Sue also reported that Sue Vernier, Niles Rosenquist, Richard Vernier and Brian Taylor are eligible to serve again. In addition, existing directors Phil Copp, Pat Copp and Jim Kimsey are eligible for new term ending 2028. Two vacancies for term ending 2026 are still needed.

Items from the floor:

Sue Vernier reported during the snows they had a Sapsucker and Mockingbird visit the feeders. Alex Gansmann reported a Pine Siskin, Purple Finch, Brown Thrasher and Eastern Phoebe. Brian Taylor reported a member found a Great Egret on the Posey County Christmas Bird Count.
